I declare that I am at least 21 years of age. In the event that VSC accepts this application, which will be evidenced by the signature (below) of a person with the authority to bind VSC, I agree that in consideration of such acceptance, I shall accept and assume the following obligations: 1) I shall abide and be bound by the bylaws of VSC, a copy of which were made available to me; 2) I assume any and all risk of my own personal injury and/or death arising from or in any way related to my participation in any services, event or activity organized by or on behalf of VSC; 3) I agree not to make any claim against VSC and not to commence any action against VSC to seek damages for any personal injury and/or death or loss, cost or expense I may suffer whether caused by the negligence or gross negligence of VSC or in any way related to my participation in any services, event or activity organized by or on behalf of VSC; 4) I further agree not to make any claim against VSC for the loss of, theft of or damage to personal property arising from or in any way related to my participation in any services, event or activity organized by or on behalf of VSC; 5) I agree not to bring any action or proceeding against any natural person or corporation who or which might assert a third party claim against VSC for injury, death or any loss of any kind whatsoever arising from my participation in any services, event or activity organized by or on behalf of VSC, and in the event I do so, in spite of the provision of this paragraph, I agree to indemnify VSC for any legal fees it incurs and to pay an amount equal to any damages and/or costs awarded against VSC to it and to pay VSC the cost of any settlement entered into by VSC at its sole discretion; 6) In the event that a claim is made of VSC or an action is commenced against it by any other natural person or corporation arising from my alleged negligence, I shall indemnify VSC for any legal costs it incurs and to pay an amount equal to any damages and/or costs awarded against VSC to it and to pay VSC the cost of any settlement entered into by VSC at its sole discretion; 7) The foregoing paragraph shall apply to and bind my heirs, successors, assigns and shall enure to the benefit of any and all directors, officers, employees, agents, insurers, successors and assigns of VSC; 8) I understand that memberships are non-refundable and non-transferable.
