All travel arrangements made on behalf of the VOYAGEURS SKI CLUB for the 2006/07 Charter are provided by Skican.

PLEASE NOTE: All Cheques are to be made payable to the 'VOYAGEURS SKI CLUB'. Scheduled payments will be accepted no later than 9:00 PM on the due date. Postdated Cheques or authorization to charge your credit card for all due dates will be accepted. NSF cheques are subject to a \$25.00 fee that must be paid by the participant prior to being reinstated to 'Member in Good Standing' status. All Trip payments must be made as per the payment schedule above. Alternative payment arrangements must be made IN ADVANCE of the scheduled payment due date(s) with the Charter Trip Director. Club credits cannot be used to cover penalties.

Cancellation Policy:

The Insurance payment is non-refundable.

Cancellation penalties are:

(A) Up to 45 days prior to departure: loss of \$300.00 per person

(B) 45 days or less prior to departure: 100% non-refundable.

Airfare portion may be subject to additional cancellation or change charges, payable by the participant.

Participants who 'No Show' (missing the Flights or Transfers), or are denied entry/travel for any reason, forfeit the total holiday cost and are solely responsible for any additional costs that may be incurred.
